The following outlines the A-Plus™ Loyalty Rewards Points Redemption procedures. For redemption purposes, members are reimbursed 1 dollar (US or Canadian) for each A-Plus™ Loyalty Rewards Point claimed. (One Point is equal to \$1 USD).

A-Plus™ Loyalty Rewards Points are not legal tender and cannot be used to pay for paint purchases.

1. Member must submit a paid itemized purchase receipt(s) or detailed invoice(s) in order to redeem points. A quote, credit card or account statement is not an acceptable receipt. Note: The expenses to be reimbursed must have already been incurred – services not yet received will be excluded, even if paid for in advance.
2. Member must sign A-Plus™ Loyalty Rewards Points Redemption Form in order for it to be processed.
3. A Sherwin-Williams credit account must be open to charge in order to process redemption request.
4. Invoice(s) can only be submitted once for redemption.
5. Invoice(s) must be submitted within 6 months from the date of purchase for redemption.
6. Member must keep \$495.00 A-Plus™ Loyalty Rewards Points balance in their account to cover the annual renewal fee that is automatically deducted on the membership anniversary date each year.
7. Upon approval of redemption, member will receive a credit adjustment at the end of the month. The credit adjustment will be listed on the member's monthly Sherwin-Williams Accounts Receivable statement. A check can not be issued for the credit adjustment.
8. Members must retain copies of claims submitted. Claim information cannot be returned – Completed redemption forms and receipts/invoices should be faxed or mailed to:
9. If Member sells, transfers, or otherwise disposes of business, all A-Plus™ Loyalty Rewards Points shall be forfeited. A-Plus™ Loyalty Rewards Points are non-transferrable.
